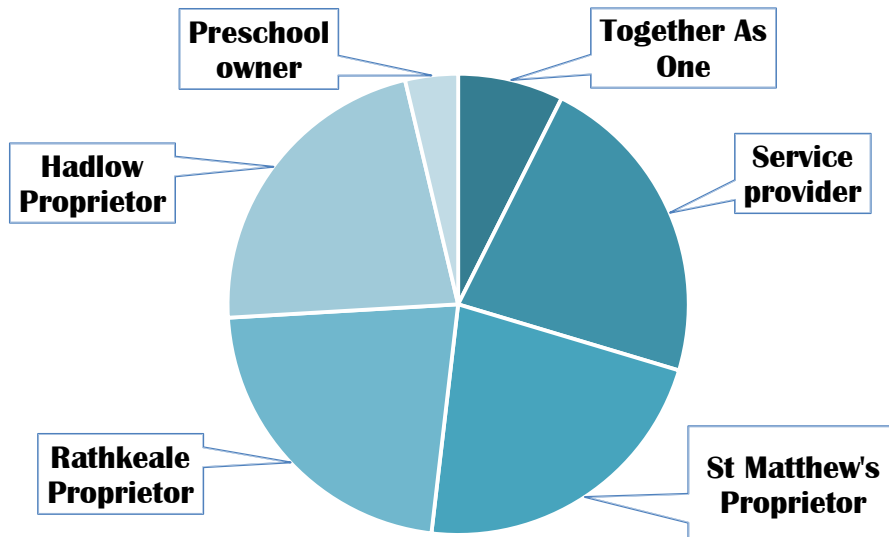


TRINITY SCHOOLS TRUST BOARD

WHO AND WHAT IS IT?

TSTB are the **Board of Proprietors** for Hadlow, Rathkeale and St Matthew's and are the owners of the schools, land and buildings. They are responsible for the **Special Character** of the schools and uniquely they are also a **Service Provider** to the schools. They have signed an **Integration Agreement** with the Crown that established a Board of Trustees to govern each school.

THE 6 BIG TSTB ACTIVITIES



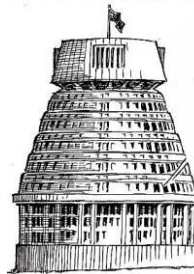

HOW HAVE THE TRINITY SCHOOLS EVOLVED OVER THE YEARS?



- 1913 ST MATTHEW'S CHURCH BUYS MISS ELLA HAMPTON'S PRIVATE SCHOOL
- 1914 THE PARISH OPENS A RENAMED ST MATTHEW'S SCHOOL
- 1915 THE PARISH PASSES GOVERNANCE TO THE NEWLY ESTABLISHED ST MATTHEW'S TRUST BOARD
- 1929 HADLOW SCHOOL OPENS
- 1955 ST MATTHEW'S TRUST BOARD BUYS HADLOW
- 1964 ST MATTHEW'S TRUST BOARD OPENS RATHKEALE
- 1983 ST MATTHEW'S TRUST BOARD CHANGES ITS NAME TO TRINITY SCHOOLS TRUST BOARD
- 1992 ST MATTHEW'S AND RATHKEALE INTEGRATE
- 1999 HADLOW SCHOOL INTEGRATES AND HADLOW PRESCHOOL REMAINS PRIVATE
- 2012 THE TRINITY *TOGETHER AS ONE* STRATEGIC DIRECTION IS INTRODUCED
